**Code Amendment Stop Signs:** Police Chief, Frank Kosman, presented to the Committee an ordinance amending the Bensenville Village Code Title 5, Traffic and Motor Vehicles, Chapter 3, Streets and Intersections Section 5-3-9, Stop Intersections.

Chief Kosman stated the amendment will place a four way stop at Ridgewood and 2<sup>nd</sup> Avenue.

**Agreement:** Assistant Director of Community & Economic Development, Mark Rysavy, presented to the Committee a resolution approving the amendment to the contract for architectural services for a shared Police facility with FGM Architects, Inc.

President Soto stated he would like this matter to have an RFP as this has always been the Village's practice for projects of this matter.
