**229 West Grand Ave.:** Director of Community & Economic Development, Scott Viger, presented to the Committee an ordinance for a request by Wheaton Massage Corporation to transfer the conditional use permit granted in Ordinance #54-2013 from Lavenda Spa, LLC to Wheaton Massage Corporation located at 229 West Grand Avenue, Unit J within an existing C-2 Highway Commercial District.

**Text Amendment:** Director of Community & Economic Development, Scott Viger, presented to the Committee an ordinance for a text amendment related to Political Campaign Sign definitions and signs.

Trustee Ridder suggested allowing 72 hours after elections for sign to be removed. There were no objections from the Committee.

President Soto suggested removing the two foot setback for Commercial Districts. Mr. Viger stated the current code allows for a five foot setback for Commercial Districts and that the proposed ordinance is an improvement for Commercial Districts.

**Motion:** Trustee Bartlett made a motion to approve this item for placement on a future Village Board Meeting Agenda for action as presented. Ridder seconded the motion.

All were in favor. Motion carried.

**2014 Zoning Map:** Director of Community & Economic Development, Scott Viger, presented to the Committee an ordinance for the adoption of the Village's Zoning Map for 2014.
