**MINUTES OF THE INFRASTRUCTURE AND ENVIRONMENT COMMITTEE**  
**May 20, 2014**

**CALL TO ORDER:** Chairman Wessler called the meeting to order at 7:47 p.m.

The April 15, 2014 Infrastructure and Environment Committee Meeting minutes were presented.

**Motion:** Chairman Wessler made a motion to approve the minutes as presented. President Soto seconded the motion.

**Corrective Asphalt Materials, LLC:**

Director of Public Works, Joe Caracci, presented to the Committee a resolution authorizing a contract with Corrective Asphalt Material, LLC for 2014 pavement preventative maintenance program in the amount of \$42,877.25.

**Technologies:** Director of Public Works, Joe Caracci, presented to the Committee a resolution authorizing a contract with MDS Technologies, Inc. (MDST) for 2014 pavement evaluation study in the not-to-exceed amount of \$22,600.00.

**CDBG Phase IV:** Director of Public Works, Joe Caracci, presented to the Committee a resolution authorizing award of a construction contract to A-Lamp Concrete Contractors, Inc. for the Volk Brothers CDBG Project – Phase IV in the amount of \$1,372,758.00.

Trustee O'Connell stated he was approached by an Engineer whom stated that the berming at Fenton for Stormwater management is not working properly.
