Mr. Finner stated last year was the first year in which the Village hired Addy Pyrotechnics to perform the fireworks display on the 4th of July at LibertyFest. Mr. Finner stated Addy won the contract through a competitive bid and put on a remarkable and unique show that received rave reviews. Mr. Finner stated this year, Addy has increased their price from \$40,000 to \$47,000 to account for their costs as well as to improve their production this year. Mr. Finner stated while not the low bid, staff believes that the results of Addy's show last year are worth the additional cost based on their unique presentation. Mr. Finner stated the 2015 Budget anticipated the \$47,000 cost and staff recommends approval.
