Chief Kosman stated this agenda item follows a suggestion by the Village of Addison and is another benefit of our shared Police Dispatch Center. Chief Kosman stated the Addison Consolidated Dispatch Center has the authority to activate Bensenville's Outdoor Warning Sirens and their technology also allows the Villages of Addison and Bensenville to activate each other's sirens in the case of an emergency when either municipality cannot activate their own siren. Chief Kosman stated in order to take advantage of this redundancy, an Intergovernmental Agreement is required. Chief Kosman stated Staff recommends approval of this item.
