2016 Zoning Map: Director of Community and Economic Development, Scott Viger, presented to the Committee a Resolution adopting Amendments to the Official Zoning District Map for the Village of Bensenville for 2016.

Mr. Viger stated the Village prepares and approves a Zoning Map each year as prescribed by State Statute. Mr. Viger stated there is only one change to the map this year, the rezoning of the former Bensenville Elementary School at 115 - 119 East Green Street to C - 2 Highway Commercial. Mr. Viger stated staff recommends adoption of the updated map.

Chairman O'Connell asked for an update regarding the La Huerta parking lot project.
