Mr. Summers stated there are a total of 24 bikes that have not been claimed by their owners during the statutory time period of 6 months from the time of their recovery or eligibility for release. Mr. Summers stated the Bensenville Police Department is seeking approval to donate the bicycles to Working Bikes, a state registered charitable organization.

Trustee Wessler asked if the Bensenville Food Pantry was offered the opportunity to accept the bikes as a donation first. Police Chief, Frank Kosman, stated he had not contacted the Bensenville Food Pantry but would if the Committee desired.

**Motion:** Trustee DeSimone made a motion to approve this item for placement on a future Village Board Meeting Agenda for action, *contingent upon the offering of the donated bikes to the Bensenville Food Pantry first.* Trustee Jaworska seconded the motion.

All were in favor. Motion carried.
