**Motion:** Trustee Bartlett made a motion to approve the minutes as presented. Trustee O'Connell seconded the motion.

**304 N. Spruce**

**Street:** Director of Community & Economic Development, Scott Viger, presented to the Committee an ordinance authorizing a two lot subdivision of 304 N. Spruce. At the October 10, 2011 Community Development Commission Meeting, The Commissioners voted six to zero recommending approval of the subdivision. The proposed lots already have their one tax id number. The petitioner has stated he has a buyer for the property once a house is built. Staff recommends approval.

**124 South**

**Church Road:** Director of Community & Economic Development, Scott Viger, presented to the Committee an ordinance authorizing a driveway width variance at 124 South Church Road. At the October 10, 2011 Community Development Commission Meeting, the Commissioners voted six to zero recommending approval of variance. The work was started by a contractor that did not properly obtain a permit. The homeowner was unaware of the issue at the time. Chairman Peconio expressed concern in regards to the potential flooding to the neighbor's property if the driveway is approved. Staff stated the proposed driveway will have an installed lip that will cause the water to flow into the middle of the driveway. Staff stated the grass will be restored where it has been removed. Trustee Wesseler questioned the amount of vehicles currently parked in the driveway. Staff stated all five family members currently living in the home drive SUVs and space is limited. Staff recommends approval.
