**Mobile Phone
Service:**

Assistant Public Works Director, John Anderson, presented to the Committee a resolution for approval of a contract for mobile phone service. The Village of Bensenville received bids from five different companies. The Village is currently under contract with T-Mobile. The contract expires at the end of October. The lowest bid was received from Sprint. The Village will receive 70 phones. 30 blackberry devices and 40 flip phones. Direct connect will be available. The contract can be terminated at anytime with no charges. The Village has a 60 day trial with Sprint. The phone numbers will remain the same.
