MINUTES OF THE PUBLIC SAFETY COMMITTEE MEETING

Title 5, Chapter 7 Vehicle Tows: Police Chief, Frank Kosman, presented to the Committee an ordinance restating Title 5, Chapter 7 of the Village Code that is entitled Motor Vehicle Tows. At the November 15, 2011 Committee Meeting, it was determined to have a survey conducted with the policies from surrounding Communities. Chief Kosman conducted the survey from 22 Communities and presented to the Committee.
