Mr. Caracci stated the Village Board approved a similar contract last year and Staff has made the decision to terminate the old contract passed on performance issues. Mr. Caracci stated the projected went out to bid and Winkler's Tree Service, Inc. came in the lowest. Mr. Caracci stated Staff recommends approval.

Trustee O'Connell asked how the RFP was distributed and why the types of requirements were made. Mr. Caracci stated in order for the Village to receive grants for the project, certain requirements were necessary.
