**El Toreo  
Liquor License:**

Police Chief, Frank Kosman, presented to the Committee an ordinance amending the Bensenville Village Code Title 3 – Chapter 3 – Liquor Regulations, 229 West Grand Venue #2W, El Toreo Market. Chief Kosman stated El Toreo currently holds a Class F license that allows the sale of packaged beer and wine. El Toreo has applied for a Class B license which would allow for the sale of packaged spirits along with packaged beer and wine.

Trustee Wessler stated his concerns with the amount of liquor licenses in town.

Liquor License:**

Police Chief, Frank Kosman, presented to the Committee an ordinance amending the Bensenville Village Code Title 3 – Chapter 3 – Liquor Regulations, 438 South York Road, Mamma Maria's Restaurant. Chief Kosman stated Mamma Maria's currently holds a Class E2 license that allows the sale of beer and wine when food is offered. Mamma Maria's has applied for a Class E1 license which would allow for the sale of spirits along with packaged beer and wine when food is offered.
