481-485

Podlin Dr.:

Director of Community & Economic Development, Scott Viger, presented to the Committee an ordinance granting approval of a Class 6B for 481-485 Podlin Drive, DMD Services.

There were no questions from the Committee.

Trustee Ridder made a motion to approve this item for placement on a future Village Board Meeting Agenda for action as presented. President Soto seconded the motion.

1100 N. Rt. 83:

Director of Community & Economic Development, Scott Viger, presented to the Committee an ordinance granting approval of a conditional use permit to allow a sign height variance for 1100 North Rt. 83, Bacci Pizza.

Mr. Viger stated the Community Development Commission recommended approval of the request unanimously with conditions recommended by Staff and to allow the sign to be placed at fourteen feet tall. Mr. Viger stated Staff's recommendation is to not exceed twelve feet in height.

Trustee Bartlett asked what the sign height for MB Financial was. Mr. Viger stated the MB Financial sign was eighteen feet tall.

Trustee Bartlett suggested allowing the maximum sign height to be eighteen feet tall to match the MB Financial sign.

Motion:

Trustee Ridder made a motion to place this item on Standing Committee with a maximum allowance of eighteen feet in height and a base width reduction. Trustee Bartlett seconded the motion.
