**TIF Request:** Village Manager, Michael Cassady, presented to the Committee a consideration of a request from the Bensenville Community Library to use \$20,000 in TIF funds for Technology Training.

Mr. Cassady stated the funds would be used to extend the current computer job training program offered by the Bensenville Community Library. Mr. Cassady stated the current program is funded by a grant that will soon end. Mr. Cassady stated the proposed funds will allow the successful program to operate for an additional year.

Trustee Wesseler asked if there were any issues with lending the TIF funds to the Library. Mr. Cassady stated Staff and Village Attorneys have reviewed the TIF requirements and found no conflicts.
