**VOB Variance:** Director of Public Works, Joe Caracci, presented to the Committee a resolution approving the grant of a variance to the Village of Bensenville as it relates to the site storage runoff requirements of the DuPage County Stormwater and flood plain ordinance to pay fee-in-lieu in the amount of \$437,836 to the Village of Bensenville for the improvements related to the Wastewater Treatment Plant Upgrade Project.

President Soto raised concern with the recent changes to the plans and cost associated to the Village. President Soto indicated he would like to see a concept plan from the State of Illinois to help with potential traffic in Bensenville.

Trustee Jarecki asked for the total amount of lost tax dollars to the Village from the taking of certain properties by the State for the project.

Members of HR Green were present and indicated they would meet with member of the Board an Public to address all concerns.

### **Winkler's Tree Service**

**Agreement:** Director of Public Works, Joe Caracci, presented to the Committee a resolution authorizing the execution of a contract with Winkler's Tree Service for the 2013 Parkway Tree Pruning Program in the amount of \$39,054.00.

Mr. Caracci stated this was year three of the tree pruning program and would be year two with Winkler's Tree Service. Mr. Caracci stated there are roughly 771 trees in phase five.

Trustee Ridder asked that Gloria Jean Drive be added to the map.

Chairman Wessler asked for an update regarding old street signs. Mr. Caracci stated the old street signs will be on sale at the 2013 Holiday Magic event.

Chairman Wessler asked for an update on the McDonald's construction on the corner of Irving Park Road and Mason Street. Director of Community & Economic Development, Scott Viger, stated McDonald's is awaiting site improvement from the property owner and assuming those improvements are to be completed, construction of the McDonald's will begin in spring 2014.

Chairman Wessler asked when the Route 83 resurfacing will be completed. Mr. Caracci stated the project is scheduled to be completed by October 31, 2013 and that he has not received any notification of any delays.

Chairman Wessler asked for an update on the barbwire along York Road. Mr. Cassady stated the property was owned by the O'Hare and that he was meeting with them in the near future.

Trustee O'Connell asked Staff to review the crossing at Franzen Street and Grove Street.
