MINUTES OF THE PUBLIC SAFETY COMMITTEE MEETING
July 15, 2014

CALL TO ORDER: Chairwoman Ridder called the meeting to order at 6:00 p.m.

Approval of Minutes: The June 17, 2014 Public Safety Committee Meeting Minutes were presented.

IGA School District 2: Police Chief, Frank Kosman, presented to the Committee a resolution authorizing an Intergovernmental Agreement between the Village of Bensenville and Bensenville Elementary School District 2 for school resource officer.

Chief Kosman stated for the past seven years School District 2 has utilized a Bensenville Police Officer as a School Resource Officer during the school year. Chief Kosman stated this year Officer Kevin Banks was selected for the 2014/2015 school year. Chief Kosman stated per the Intergovernmental Agreement (IGA) with District 2, they will reimburse the Village \$84,420 in total for the services of Officer Banks for approximately 179 days of the year. Chief Kosman stated when not assigned to District 2, Officer Banks will be re-assigned to patrol or investigations. Chief Kosman stated staff recommends approval of the IGA, which has already been approved by District 2.

There were no questions from the Committee.

Motion: Trustee Janowiak made a motion to approve this item for placement on a future Village Board Meeting Agenda for action as presented. Trustee Jarecki seconded the motion.

All were in favor. Motion carried.
