**ABSENT:** Johnson, Williams

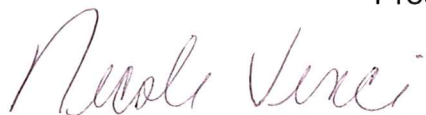
Trustee Tralewski made a motion postpone consideration of the settlement issue discussed in executive session. Trustee Mandziara seconded the motion.
