**MINUTES OF THE TECHNOLOGY**

The April 15, 2014 Technology Committee minutes were presented.

**CDS Office  
Technologies:**

Chief Technology Officer, Andy Schaeffer, presented to the Committee a resolution approving an agreement with CDS Office Technologies for leased copiers and printers, parts and labor for the monthly amount of \$3,471.

Mr. Schaeffer stated the Village's copier and printer lease and service agreement expires on July 31, 2014. Mr. Schaeffer stated staff solicited proposals from three vendors for a new agreement. Mr. Schaeffer stated staff recommends contracting with CDS Office Technologies for \$3,471/month, which will result in an annual savings of \$6,000. Mr. Schaeffer stated that not only will the Village save money in this new agreement, but all printers and copiers will be replaced as well. Mr. Schaeffer stated this price will increase when the new Police Headquarters comes on-line due to the increase in equipment. Mr. Schaeffer stated staff recommends approval.
