**Imperial  
Surveillance:**

Chief Technology Officer, Andy Schaeffer, presented to the Committee a resolution executing an agreement with Imperial Surveillance, Inc. for installation and maintenance of security cameras and access doors at the Village Hall for an amount not to exceed \$46,039.94.

Mr. Schaeffer stated a new security system is included in both the 2015 Strategic Plan and Budget. Mr. Schaeffer stated the cameras and door access controls are past their useful life and need to be replaced. Some of the cameras are no longer operational and those that remain are low definition and do not have the functionality of newer cameras. Mr. Schaeffer stated Imperial Surveillance, Inc. is the same company that installed security cameras and accompanying software in the Recreational facilities. Mr. Schaeffer stated due to their excellent performance and pricing, staff recommends hiring Imperial again to upgrade the security system in Village Hall for a price not to exceed \$46,039.94, which is under budget.
