**School District No. 2 Resource Officer:** Police Chief, Frank Kosman, presented to the Committee a Resolution Authorizing an Intergovernmental Agreement between the Village of Bensenville and Bensenville Elementary School District 2 for a School Resource Officer.

Chief Kosman stated for the past seven years, the Village of Bensenville and School District 2 execute an intergovernmental agreement (IGA) to assign a Bensenville Police Officer as a school resource officer for days that school is in session. District 2 in turn reimburses the officer's cost to the Village. Chief Kosman stated School District 2 has already authorized execution of this year's IGA, therefore staff recommends the Village Board also approve a Resolution authorizing execution of the IGA.
