# Noise Reduction Efforts

8

- May 29, 2015 – MOU signed by State Legislators and CDA to communicate solutions available to address aircraft noise
- Primary goals for actions:
  - Allow O'Hare to operate safely and efficiently
  - Analyze and mitigate noise impacts to the extent allowable and reasonable
  - Comply with all existing agreements
  - Allow O'Hare to grow
- Three meetings took place with FAiR and SOC representatives to discuss noise concerns
- 24 measures identified by CDA to address noise concerns

# Noise Reduction Efforts

9

- **Cornerstone of CDA proposal is establishing a rotational runway use program for Fly Quiet**
  - Goal is to spread the noise so no one community bears the brunt of O'Hare noise
  - Focus on nighttime first because will be easier to make changes due to lower traffic volume
  - Daytime changes significantly more difficult due to volume of operations
- **Proposed measures offered by Bensenville in CDA's Noise Task List**
  - Complete OMP Build Out
  - Modify and enhance existing preferential departure procedures
  - Consider runways 10L/28R and 10C/28C as one runway for any runway rotation evaluations due to their close proximity to one another
  - Use full runway length for nighttime departures
  - Monitor FAA evaluation of 65 DNL
  - Support Stage 4 & 5 aircraft fleet additions

# Noise Reduction Efforts

10

- Proposed measures offered by SOC in CDA's Noise Task List
  - Fly Quiet Runway Rotation
  - Utilize Runway 14R/32L while available
  - Modify existing preferential departure procedures\*
  - Enhance existing preferential departure procedures\*
  - Complete OMP\*
  - Airspace changes (Optimized Profile Descent, Performance Based Navigation)
  - Investigate new noise software (e.g. WebTrak)

\* Bensenville recommendations incorporated into SOC recommendations

# Noise Reduction Efforts

12

## **Fly Quiet II Rotation Plan Test**

- Establish rotation plan
- Alternate East and West Flow (5 knot tailwind)
- Avoid consecutive community impacts
- Reduce use of Runway 10L/28R when possible
- Conduct test and monitor period
- Bring recommendations back to ONCC for review and approval

# Noise Reduction Efforts

13

## **Fly Quiet II Rotation Plan Test (cont.)**

- ONCC voted on May 6, 2016 to move forward with rotation test plan
- Test to run for six months; then operations will revert to how runways are currently used
- Test should start in July timeframe
- Rotation schedule to be published ahead of time
- CDA/ONCC is establishing a website to survey residents on whether or not the rotation plan is helping

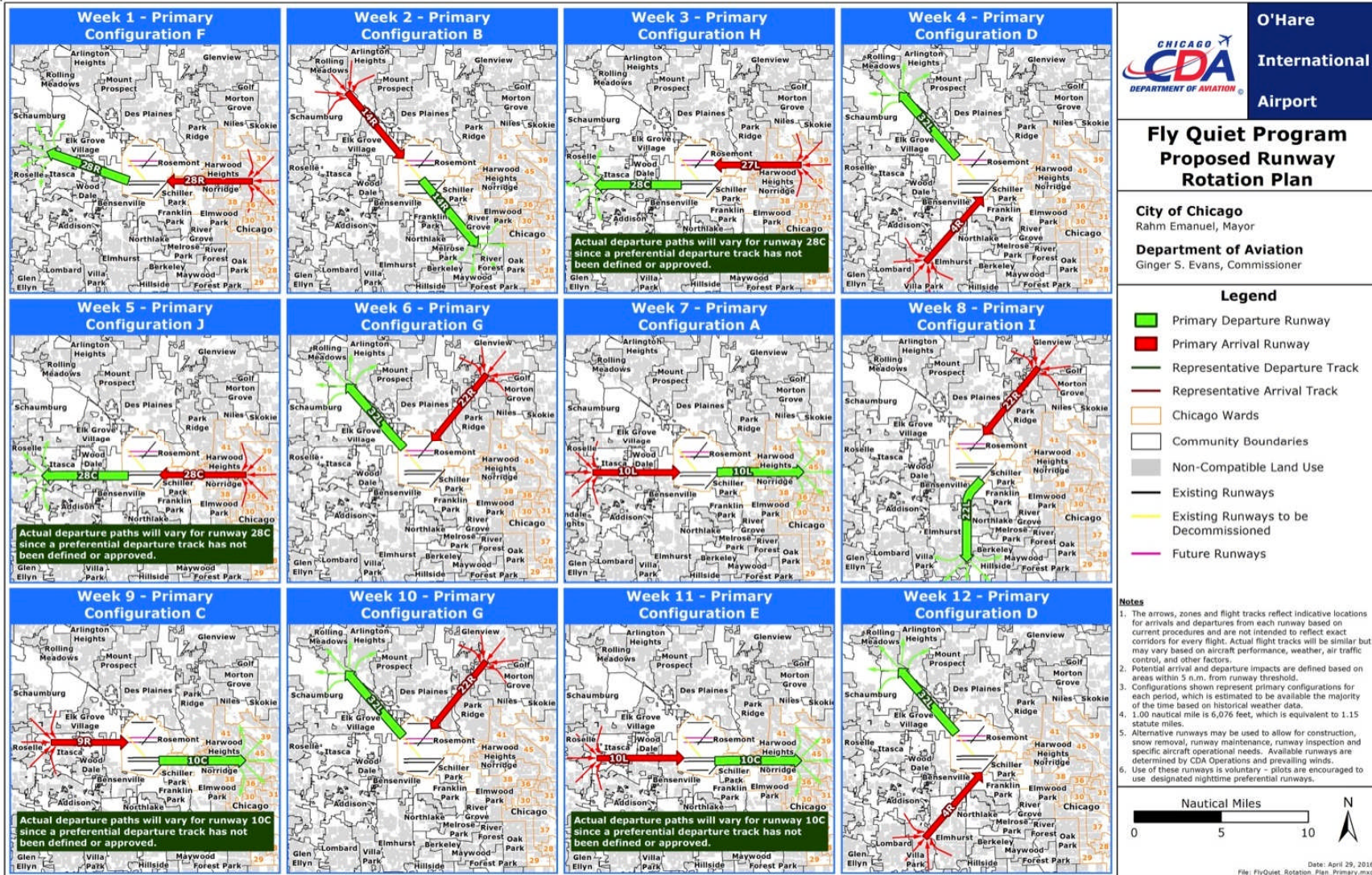

## **Fly Quiet II Rotation Plan Test (cont.)**

- Ad-Hoc Fly Quiet Committee met this morning to discuss how results will be collected and tabulated
- Website developed by CDA explaining test and containing survey for residents to provide feedback
- Honest feedback on survey is important; survey not meant as avenue for complaints
- Results of test plan, including resident feedback, will be discussed by ONCC to determine if rotation plan should be permanently added to Fly Quiet Program

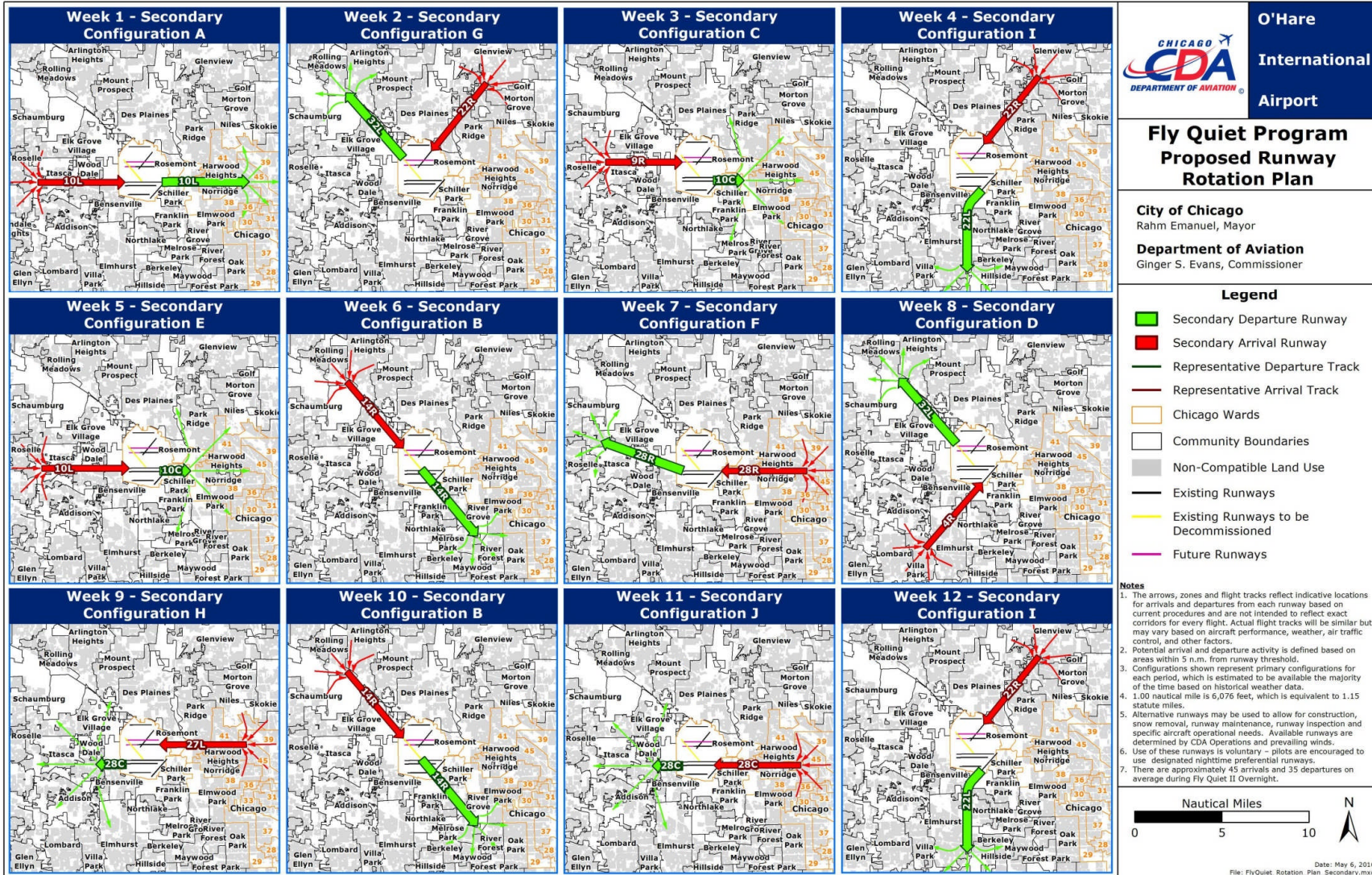


# Primary Runway Rotation

- **Work to draft ballot referendum questions for November, 2016 Ballot**
- **Work with ONCC to refine rotation test plan as needed**
