**MANAGERS
REPORT:**

Village Manager, Evan Summers, addressed the Public Comments made earlier in the meeting. Mr. Summers stated the Lakota Transit

Plan of 2011 called for wider sidewalks which would mean parallel parking rather than diagonal parking. Mr. Summers stated the AECOM CEDS Study from 2013 called for the removal of diagonal parking along Center Street along with the 2015 Study that indicated the Village does not have a parking problem in downtown Bensenville, it has a parking management problem. Mr. Summers stated the Active Transportation Study from 2016 calls for a bike boulevard on Green Street, which wouldn't allow diagonal parking. Mr. Summers stated the Village hosted numerous Public Outreach as well. Mr. Summers the Village hosted a Pubic Meeting on December 13, 2016, June 13, 2017, June 19, 2018, September 25, 2018 along with a Public Hearing on September 25, 2018. Mr. Summers stated that Green Street is a FAU Route. Mr. Summers sited a Section from the Illinois Vehicle Code; Section 11-13- 04-C. Mr. Summers stated when the redevelopment of downtown is complete, on street parking will increase from 78 spaces to 94 spaces. Mr. Summers stated his recommendation to the Village Board will be to move forward with the proposed project.

We represent business owners on Center Street, Green Street or Addison Road south of the train tracks. We are all opposed to the proposed street and sidewalk construction beginning this Spring. We all believe that closing down the streets and putting in parallel parking will permanently hurt our businesses. One of the situations plaguing downtown Bensenville is the limited amount of parking. This proposal will make it worse. By putting in parallel parking, the number of street parking spaces will be reduced by as much as 67% plus it is much more difficult to park using parallel parking especially for senior citizens. The construction work which took place last year north of the railroad tracks and at the Village parking lot took an incredible amount of time. For many of us, even a short period of time when our entrance roads are closed or with limited access will severely hurt business income and may even force some of us to close. Finally, we are also troubled by the limited amount of information which has been provided to us by the Village regarding this project.


