President DeSimone announced the Church Road Bike Path Project is also moving along on schedule. President DeSimone announced the underground storm sewer work is complete and the contractor has begun removing existing sidewalks and driveway aprons in preparation of the new path installation. President DeSimone announced the next couple of weeks will include remaining sidewalk and apron removals and aggregate (stone) base course preparations. President DeSimone announced once removals are complete, the framing of concrete driveway aprons and sidewalks will begin.
