R-85-2022:**

President DeSimone gave the summarization of the action contemplated in **Resolution No. R-85-2022** entitled a **Resolution Authorizing an Intergovernmental Agreement Between the County of DuPage and the Following Municipalities: Village of Itasca, City of Wood Dale, Village of Roselle, Village of Bensenville, Village of Bartlett, City of Elgin, The Village of Hanover Park and the Village of Schaumburg for DuPage to Join the Stop CPKC Coalition Opposing Merger of the Canadian Pacific Railway and Kansas City Southern Railroads as Proposed.**

**PRESIDENT'S

President DeSimone stated over the last week, he has been getting many calls from residents who want clarification on the Park District's seemingly 180 decision unilaterally change direction on White Pines Golf Course. President DeSimone stated he is still trying to understand the order of events but is starting to believe that the Park District may never have really intended to redevelop the golf course in the first place. President DeSimone stated that it appears that without a solid redevelopment plan or concept in place, the Park District was using the potential sale of White Pines Golf Course as an excuse to try and raise taxes on our residents by \$20,000,000 all along. President DeSimone stated \$20,000,000 in taxpayer funds to pay for a club house, by their own admission; 95% of our residents will never use. President DeSimone stated he has concerns with that.
