Public Hearing: CDC Case Number 2010-16
Petitioner: Humberto Lagunas & Eduardo Lagunas (Warrior Scrap Metal)
Location: 1141 E. Green Street
Request: Conditional Use Permit; Recycling Center

Eduaedo Lagunas, Owner, and Bob Gill, Property Owner were both present and sworn in by Chairman Markowski. Mr. Lagunas presented to the Commissioner a commitment letter from Excel Environmental, Inc to become the recycling company for Warrior Scrap Metal for hazardous materials. (Exhibit A) Warrior Scrap Metal could not find a company to properly dispose of freon. Until a company is hired, Warrior Scrap Metal will not accept any materials containing freon. There has been not details finalized with Excel Environmental, Inc regarding a pick up schedule or containers being supplied. Warrior Scrap Metal currently closed their facility in Melrose Park due to size. They are seeking a bigger location. All sorting will take place inside the building. Mr. Gill is currently addressing the code issues with the building. Warrior Scrap Metal is open to the public. Commissioner raised concern with handicap parking. There was no denotation of handicap parking on the site plan. There was no public comment.

Public Hearing: CDC Case Number 2010-15
Petitioner: Joseph Calzante
Location: 430 & 434 S. York Road
Request: Site Plan Review

Joseph Calzante, property owner, and Marshall J. Subach of Hunt, Kaiser, Aranda & Subach, Ltd. were both present and sworn in by Chairman Markowski. Mr. Calzante is seeking approval for a site plan for additional parking. Mamma Marias will be adding forty five parking spaces and will relocate curb cuts. IDOT does not have any jurisdiction with the curb cuts on York Road, they fall within Bensenville's jurisdiction. Loading and unloading will take place behind the building in the public ally. Mamma Marias will keep the current parking. All code and permit requirements will be met. Commissioner Ramirez raised concern with the lack of a landscaping plan. There were no given details on the type of screening or type of trees being planted. Village Staff will work with Mr. Calzante regarding the issues. There was no public comment.
