Assistant Village Manager for Community Development, Steven Marshall, explained that strip malls are required, by ordinance, to submit a Master Sign Plan. Compliance is generally triggered when there is a sign change or improvement. The ordinance allows old signs to remain but any new or improved signs must follow a Master Sign Plan. All sign plans will go before the Village Board for final approval. Compliance with the Master Sign Plan ordinance will be gradual.

Request: To consider a Text Amendment to add "Tattoo/Body Piercing Parlor" to the I-4 General Industrial Section 10-9D-3: Conditional Uses

Chairperson Pro-Tem Markowski called Public Hearing CDC Case No. 021207-3 to order.

Assistant Village Manager for Community Development, Steven Marshall, explained that currently, if a specific use is not listed in the Zoning Codes, the Director of Community Development may determine the use to be similar to any listed use in a particular zoning district. In this instance, the Director of Community Development believes that Tattoo/Body Piercing Parlors fall under the adult use category which is listed in the I-4 Zoning District. The proposed text amendment will specifically list Tattoo/Body Piercing Parlors as a Conditional Use in the I-4
