**211 Beeline

CDC case# 1051109-1 was continued until the Community Development Commission meeting in July. Staff asked for a continuance on 211 Beeline, Unit 12 discussion until the July Economic & Community Development Committee of the Whole meeting.

There were no objections from the Committee.

**16W598 THIRD:** Staff discussed results from the Community Development Commissioners meeting held on June 8, 2009. The Community Development Commission recommended approval for a Pre-Annexation Agreement with 16W598 Third Ave.

Trustee Johnson made a motion to approve this item for placement on a future Village Board Meeting Agenda for action. Trustee Wesseler seconded the motion.

All were in favor

Motion carried.

Chairman Peconio shared ideas with the Committee to change meeting times. Chairman Peconio would like to have the Community Development Commission meet on the first Monday of every month. He would like the Economic & Community Development Committee to meet on the seconded Monday of every month. This will allow a faster process for approval on CDC cases. Staff will work on a new schedule and present it to the Committee at a future meeting.

**AS SUBMITTED:** The Village of Bensenville was recently awarded a \$100,000 RTA Grant. The grant will need to be executed within a year. There is a \$25,000 payback that the Village is responsible for. The money is currently not budgeted. A budget transfer can be done for the pay back.

**INFORMATIONAL ITEMS:** The Census will begin on April 1, 2010. In 2000 only 56% of Bensenville was reported due to low participation. This was the worst percentage of all communities. Village staff is working on a way to inform the residents of the importance of the Census. A report will be presented to the Committee in a future meeting.

Director of Community Development, Scott Viger, shared upcoming CDC petitions with the Committee.

**ADJOURNMENT:** Trustee Johnson made a motion to adjourn the meeting. Trustee Adamowski seconded the motion.

All were in favor.

Motion carried.

Chairman Peconio adjourned the meeting at 6:25 p.m.
