Mr. Viger stated the public hearing was held for this matter on June 11, 2012 and the Community Development Commission recommended approval of the conditional use with a five to zero vote. Mr. Viger stated the Community Development Commission recommended denial of the variance with a zero to five vote. Mr. Viger stated Staff also concurs with the recommendation from the Commission and recommends approval of the conditional use permit and denial of the variances.

Mr. Viger stated Staff recommends denial of the text amendment. Mr. Viger stated that Gem Construction and the Village of Bensenville have entered into a settlement agreement and the property will be vacated no later than July 31, 2012.
