The June 19, 2012 Community & Economic Development Committee minutes were presented.

349 S. Walnut: Director of Community & Economic Development, Scott Viger, presented to the Committee an ordinance for three variances for the property located at 349 S. Walnut. Mr. Viger stated the public hearing was held for this matter on July 9, 2012 and the Community Development Commission recommended approval with a five to zero vote based of Staff recommendations. Mr. Viger stated Staff also recommends approval. James Baker, property owner, was present and expressed his frustration with the Committee regarding his experience with the Village.

125 Grand Avenue: Director of Community & Economic Development, Scott Viger, presented to the Committee an ordinance approving a planned unit development to allow for a freestanding pole sign at 125 W. Grand Avenue. Mr. Viger stated the public hearing was held for this matter on July 7, 2012 and the Community Development Commission recommended approval with a five to zero vote. Mr. Viger stated Staff also recommends approval.
