**CALL TO ORDER:** Chairman Wessler called the meeting to order at 7:01p.m.

**Cardinal Fence Agreement:**

Director of Public Works, Joe Caracci, presented to the Committee a resolution authorizing a contract for installation of security gates at the Public Works Facility with Cardinal Fence in the not to exceed amount of \$23,571.

**First Transit  
Amendment:**

Director of Public Works, Joe Caracci, presented to the Committee a resolution authorizing a reduction in cost for the 2012 Dial-A-Bus Program with First Transit in the amount of \$50,990.

Chairman Wessler asked if Staff has ever looked into running the program through the Village rather than outsourcing. Mr. Caracci stated Staff has conducted a study and it has been determined outsourcing is a cheaper cost. Mr. Caracci also stated if the program was run through the Village, the Village would consume all cost of mechanical expenses.

**Kamp Synergy, LLC**

**Change Order #1:** Director of Public Works, Joe Caracci, presented to the Committee a resolution concerning the determination of the Bensenville Village Board that the change order number one with Kamp Synergy, LLC for an increase of \$20,900 is required for the SCADA System implementation for a revised contract of \$583,265.

**As Submitted:** Trustee O'Connell asked for an explanation of the new stop signs on Jefferson Street. Mr. Caracci stated there was a new pedestrian law that was passed that allows pedestrians the right of way. The current project along Jefferson is required to meet State regulations.

Chairman Bartlett ask Village Staff why all residents were receiving animal tags with their vehicle sticker renewals. Director of Finance, Tim Sloth, stated all residents were mailed the applications to insure they are aware their dogs need to be licensed with the Village.

Trustee Peconio asked for an explanation regarding the reasons there are black bags over fire hydrants throughout town. Mr. Caracci stated the hydrants are currently out of service and the Fire Department is aware.

Chairman Wessler asked for an update on the quite zones throughout the Village. Mr. Caracci stated Staff has received the necessary information and will be presenting their recommendation to the Committee at a future date.
