The January 17, 2012 Infrastructure and Environment Committee Meeting minutes were presented.

Engineering Enterprises

Agreement: Director of Public Works, Joe Caracci, presented to the Committee a resolution authorizing the execution of an engineering service agreement with Engineering Enterprises, Inc. for the Volk Brothers Phase II CDBG Project in the amount of \$85,047. Mr. Caracci stated Engineering Enterprises was selected from a five member evaluation team consisting of Village Staff and an outside individual. Mr. Carracci also stated this is a budgeted item.
