342 Briar Lane: Director of Public Works, Joe Caracci, presented to the Committee a motion to approve a request to fill-in an open ditch at 342 Briar Lane, Bensenville, Illinois. Staff had compiled a report of all the open ditched throughout Bensenville. Staff recommends denial of the project. Staff contacted Johnson Elementary School in regards to the issue. Johnson Elementary School stated they have not heard of any issues with the open ditch and at this time is not interested in funding the project.

Chairman Wessler gave a statement in reference to his concerns with children's safety during the winter. Trustee Jarecki suggested putting this project off until the construction at Johnson Elementary School is complete to see if there is a new traffic pattern to the entrance of the school that may prevent students from walking down Briar Lane. Chairman Bartlett requested a report from Staff outlining the open ditches in town that have a sidewalk. Staff was also directed to meet with the School Districts in regards to traffic patterns to each school.
