**Flood Event
July, 24, 2010:**

Director of Public Works, Paul Quinn, gave a presentation to the Committee regarding the flood event that occurred on July 24, 2010. The Village of Bensenville received 7.3 inches of rain, 19 streets flooded in town and 34 flood related calls were received by public works. Mr. Quinn shared future planned projects that will help to alleviate flooding in town.

Intergovernmental

Agreement : Director of Public Works, Paul Quinn, presented to the Committee a resolution authorizing the execution of an Intergovernmental Agreement between the Village of Bensenville and the Bensenville Park District for the construction and use of a stormwater management facility and for reconstruction of a Park District parking lot on site. This project will relieve flooding in the Church Road/Green Street area.
