Staff and the Fire District recommended that speed bumps no be installed, as an alternative the Village Board adopted an Ordinance for the installation of stop signs, which the City of Wood Dale had originally agreed to. The City of Wood Dale has since withdrawn their interest in installing stop signs. At this time the Village of Bensenville has installed playground signs and the Police will continue to patrol the area.

Agreement: Director of Public Works, Paul Quinn, presented to the Committee a Intergovernmental Agreement with DuPage County for the Grand Avenue Sidewalk Improvement Construction Cost Sharing. DuPage County will be responsible for all maintenance to the sidewalk. Staff recommends approval.
