Trustee Wesseler raised concern that Veterans that do not have a Bachelor's Degree should not be allowed to apply. **Tioga/Chippewa Traffic Plan:** Police Chief, Frank Kosman, presented to the Committee a proposed traffic plan for the Tioga/Chippewa School construction scheduled to start May 2, 2011.
