**Overweight/
Over-dimension
Vehicles:**

Police Chief, Frank Kosman, presented to the Committee an ordinance regulating overweight and/or over-dimension vehicles and a resolution authorizing a professional service agreement to administer the permit process. Per State Statute, Municipalities are allowed to issue permits for overweight/over-dimension vehicles. This will improve safety in Bensenville. The agreement will outsource the permits to a company. The company has expertise in overweight vehicles. They will be available 24/7. Surrounding communities also issue permits. This will bring revenue to the Village of Bensenville.
