**Motion:** Trustee Ridder made a motion to approve the minutes as presented. Chairman Wesseler seconded the motion.

**Associates, Inc.:** Director of Public Works, Joe Caracci, presented to the Committee a resolution authorizing the execution of an Engineering Services agreement with Trotter & Associates, Inc. for the County Line Road Water Main Replacement Project in the amount of \$35,031.

Mr. Caracci stated four firms submitted proposals for the project and after review of the submitted criteria, Trotter & Associates, Inc. was chosen for the project. Mr. Caracci stated the project will take two months for completion.

Trustee Peconio asked if the other three proposals were opened. Mr. Caracci stated the Village is not allowed to open the other bids and base their decision on the lowest price. Mr. Caracci reviewed the process for choosing an Engineer.

Trustee O'Connell asked that the reviewers be listed on Mr. Caracci's green sheet in the future.

**Vian Construction Company, Inc:** Director of Public Works, Joe Caracci, presented to the Committee a resolution authorizing the execution of a construction contract for the County Line Road Watermain Replacement Project with Vian Construction Company, Inc. of Elk Grove, IL in the amount or \$296, 218.60. Mr. Caracci stated Vian Construction Company, Inc. was the low bidder out of four.

Chairman Wesseler asked if any costs for the project can be assumed by Robert Morris University with their proposed plans. Mr. Caracci stated the project was north of the proposed plans and would not affect the area being looked at by Robert Morris University.

President Soto asked how old the watermain is. Mr. Caracci stated it was installed in the 1950s.

**Onxy Sealcoating, Inc.:** Director of Public Works, Joe Caracci, presented to the Committee a resolution authorizing the execution of a contract to Onxy Sealcoating, Inc. for parking lot sealcoating services in the amount of \$17,370.40. Mr. Caracci stated the parking lots being seal coated were the Edge Two, Public Works, George Street and Center Street lots. Mr. Caracci stated Onxy Sealcoating, Inc. was the lowest bid out of four and Staff recommends approval.

Associates, Inc.:** Director of Public Works, Joe Caracci, presented to the Committee a resolution authorizing the execution of a design Engineering Services Contract for the Village of Bensenville WWTP upgrade project with Strand Associates, Inc. in the amount of \$1,400,000. Mr. Caracci stated this project has come in over budget and a budget amendment will be forthcoming for Board approval.

Trustee Peconio asked how much was originally budgeted for the project. Mr. Caracci stated the current budget is for \$400,000.

**ITEMS:**

Director of Public Works, Joe Caracci, presented to the Committee discussion regarding the installation of Electric Vehicle Charging Station(s) on Village Property. Mr. Caracci stated there are grants available to help pay for the stations and installation. There were no objections from the Committee to allow Staff to gather pricing for the stations and installation and bring forth to a future Committee meeting for further discussion.

Jeff Pintar, PE – Project Manager from Robinson Engineering presented to the Committee a presentation in regards to quiet zones and the Village's options based on his findings. Consensus from the Committee was to eliminate all use of horns in the area and to take a tour of the area prior to any decisions. Chairman Wesseler asked Staff to contact the local businesses in the area to take a tour as well.
