16. Trustee Williams provided a brief report on the Park District Board Meeting he attended on the Village's behalf this evening. Trustee Williams presented to the Park District Board a document which was intended to begin the discussions to re-annex White Pines Golf Course to the Village. When Trustee Williams attempted to take a straw poll of the Park District Commissioners to determine their desire to begin discussions on this subject, their attorney, Mary Dicksen, advised the Commissioners not to respond.
17. Village Manager, James Johnson, provided a recap of the informational meeting for the residents and business owners in the acquisition area which took place on February 6 at Fenton High School. Attorneys Karaganis and Ryan were in attendance to update those in the acquisition area on the court cases and to explain the benefits of entering into a joint legal defense with the Village. The defense would be at no cost to the individual. Approximately 300 people attended representing 150 homes in the acquisition area. Over a dozen residents signed up at the meeting. A letter and a copy of the


