**Motor Vehicle Tows:** Police Chief, Frank Kosman, presented to the Committee an ordinance amending Section 5-7 (Motor Vehicle Tows) of the Bensenville Village Code. Chief Kosman stated the Village has received an application from Jim's Towing to be added to the list. Chief Kosman stated October is the time of year applicants can apply to be put on the tow list. Chief Kosman stated in February the Village Board amended the code to allow three towing companies in town. Since the code amendment, there have been no major issues operating with three companies. Chief Kosman expressed his concern with only having three towing companies.
