- 3. Bensenville Community Public Library Board President Alan Herff and Director Jill Rodriguez extended their gratitude to the Village President and Board of Trustees, the citizens of Bensenville who voted to support the referendum, and all those who volunteered their time to help the referendum pass. Both expressed gratitude to President Geils for his vision and to the Village Board for their cooperative intergovernmental efforts. The passage of this referendum and the Village's contribution to the library will allow the Bensenville Community Public Library to be able to provide the best service and programs to the users of the library.



WHEREAS, trees, in our city increase property values, enhance the economic vitality of business areas, and beautify our community; and


WHEREAS, trees, wherever they are planted, are a source of joy and spiritual renewal; and


WHEREAS, the Village of Bensenville has been recognized as a Tree City USA by the National Arbor Day Foundation and desires to continue its tree-planting ways;
