- 1) Village of Bensenville Permit No. 7024. (5 pgs.)


These are all of the documents that can be discovered responsive to your request.

Private information also includes home address and personal license plates, except as otherwise provided by law or when compiled without possibility of attribution to any person. " 5ILCS 140/2(c-5). Consequently, certain unique identifiers have been redacted from the records being provided.

Pursuant to Section 9 of the FOIA, 5 ILCS 140/9, I am required to advise you that I, the undersigned Freedom of Information Officer, reviewed and made the foregoing determination to deny a portion of your FOIA Request as indicated. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of FOIA, 5 ILCS 140/11.



Berg (hereinafter called the "Company") warrants the MAIN HOUSE ROOF AREA FOR 10 years from completion and separate PORCHES and BAYS for 10 years from completion to the original Customer named above, that should a leak occur in the roof due to defective workmanship or material, it will repair same without charge within a reasonable time after notice thereof, provided that Purchaser notified the Company in writing within sixty (60) days of discovery of such leak. This warranty does not cover brick work or leaks due to sheet metal items (skylights, tindecks, gutter pipes), masonry, inadequate drainage of roof due to deteriorated roof decking or sagged joists causing ponding of water on top of roof, all types of ventilators, ice storms, over ten (10) inches of snow in any one week, abnormal use or abuse of the roof system, air conditioners, framework of protruding signs, saw tooth cracked glass skylights, natural or man-made disasters (including, but not limited to, windstorms of a velocity of forty (40) miles per hour or more, hail, floods, lightning, earthquakes, or fire), vandalism, snow removal, malicious mischief, other acts of God, or any other causes beyond the Company's control. The Company will cause an inspection to be made in response to any request for services and Customer agrees that if the leak reported is determined to not be covered under the above warranty, a service charge will be paid to the Company at its then-prevailing rates for such service call. The Company shall have the right at its convenience to go onto the roof and make such repairs as it deems necessary, and to use asphalt plastic fibered cement in performing same. THE COMPANY'S SOLE OBLIGATION UNDER THIS WARRANTY SHALL BE TO FURNISH LABOR AND MATERIALS TO REPAIR LEAKS FOUND TO BE COVERED UNDER THE WARRANTY DURING THE APPLICABLE WARRANTY PERIOD AND THE COMPANY SHALL HAVE NO LIABILITY FOR ANY SPECIAL, INCIDENTAL OR CONSEQUENTIAL DAMAGES WHATSOEVER WITH RESPECT TO ANY CLAIM HEREUNDER.
