These are all the records found responsive to your request.


Please be aware that on February 25, 2014 the Village Board adopted Ordinance No. 16-2014 that requires a Real Estate Transfer Inspection (RETI) be conducted prior to most property sales within Bensenville. You may also have a right of judicial review of the denial under Section 11 of the FOIA, 5 ILCS 140/11.
