At 1434 hrs. Chief Mike Spain called me and asked that I respond to Aaron Equipment at 735 E. Green St. where they treated and transported 2 burn victims from an explosion.

I met Ken Matuszak, Operations Manager on site and he escorted me to the scene inside the shop.

Inside the large factory area, a worker was using a cutting torch to heat bolts for removal. The bolts secured the centrifuge machine to its base. The goal was to remove the machine, dismantle it, clean and rebuild it.

Witnesses say he was using the torch for about 5 minutes when there was an explosion and fire. The worker was burned to his arms and chest and received first aid from coworkers. Bensenville Fire Paramedics transported him to Loyola's Burn Center in Maywood. Another worker was transported to Alexian Brothers Medical Center in Elk Grove.

The centrifuge is a machine used to separate liquids from solids. This unit was purchased by Aaron in 2000 and placed in storage in the outdoor yard at 840 E. Green Street. It is unknown when it was last used or for what purpose.

I took several photos and video with my iPhone. I suggested they maintain the integrity of the scene, contact their insurance company, and make a report to OSHA.




