

ORDINANCE 18-87  
AMENDING COMPREHENSIVE ZONING ORDINANCE  
FROM B-2 TO B-3

BE IT ORDAINED by the President and Board of Trustees of the Village of Bensenville, Counties of DuPage and Cook, Illinois, as follows:

Section One: That certain zoning ordinance heretofore adopted the 29th of September, 1964, as amended and further amended in May, 1976, is hereby further amended.


Section Two: That part of Lot 58 in Branigar's Mohawk Terrace, being a Subdivision in Section 3, Township 40 North, Range 11, East of the Third Principal Meridian, according to the Plat thereof recorded January 17, 1956 as Document 786620 and Certificate of Correction filed January 24, 1956 as Document 787250, lying South of the following described line: beginning at a point of the East Line of said Lot 58, said point being 25.0 feet South of the Northeast corner of said Lot 58; thence Northwesterly along a straight line to a point in the West Line of Lot 58, said point being 10.0 feet south of the northwest corner of said Lot 58, in DuPage County, Illinois.  
(Commonly known as 1299 N. Spruce)


is hereby rezoned from B-2 to B-3.

Section Three: This ordinance shall be in full force and effect from and after its publication and passage according to law.
