I am pleased to help you with your May 20, 2019 Freedom of Information Act ("FOIA"). The Village of Bensenville received your request on May 20, 2019. You requested copies of the items indicated below:

"Please advise of any violations, zoning issues, liens, outstanding bills/dues, citations, copy of closed and open permits, if any, history of denied and approved permits, flood hazards, related to 343 S. Briar Lane, Bensenville, IL 60106. Please advise if Village of Bensenville service water and sewer for said property."

After a search of Village files, the following information was found responsive to your request:

- 1) Village of Bensenville Current Water Bill for 343 South Briar Lane as of May 20, 2019. (1 pg.)
- 2) Village of Bensenville Permits Issued to 343 South Briar Lane Since January 1, 2010. (1 pg.)

These are all the records found responsive to your request.


Please be aware that on February 25, 2014 the Village Board adopted Ordinance No. 16-2014 that requires a Real Estate Transfer Inspection (RETI) be conducted prior to most property sales within Bensenville. Should you believe that this Response constitutes an improper denial of your request, you may appeal such by filing a request for review within sixty (60) days of the date of this letter with the Public Access Counselor of the Illinois Attorney General's Office, Public Access Bureau, 500 South Second Street, Springfield, Illinois 62706; telephone 1-887-299-FOIA; e-mail: publicaccess@atg.state.il.us. You may also have a right of judicial review of the denial under Section 11 of the FOIA, 5 ILCS 140/11.
