I am pleased to help you with your September 6, 2019 Freedom of Information Act ("FOIA"). The Village of Bensenville received your request on September 6, 2019. You requested copies of the items indicated below:

"221 N. Franzen Street, Bensenville, IL. Open code violations, citations, liens, open permits, outstanding bills/open accounts, zoning & land use status and inspection report if available."

After a search of Village files, the following information was found responsive to your request:

- 1) Village of Bensenville Current Water Bill for 221 North Franzen Street as of September 9, 2019. (1 pg.)
- 2) Village of Bensenville Permit Issued to 221 North Franzen Street Since January 1, 2010. (1 pg.)

These are all the records found responsive to your request.



You may also have a right of judicial review of the denial under Section 11 of the FOIA, 5 ILCS 140/11.


