3. *Records sufficient to show whether any permit is open, outstanding, incomplete, past due, or unpaid in the name of **Armando Perez** or at **834 S Center St**, Bensenville, Illinois, & **14 N York Rd** Bensenville, Illinois, and whether any license or registration is incomplete, past due or expired in the name of **Armando Perez** or at **834 S Center St**, Bensenville, Illinois. As well as **14 N York Rd** Bensenville, Illinois*

Please provide me with copies of the records in electronic format at the above e-mail address. This FOIA request is not a request for a commercial purpose."


These are all the records found responsive to your request.

You may also have a right of judicial review of the denial under Section 11 of the FOIA, 5 ILCS 140/11.
