**AUTHORIZING THE EXECUTION OF EXTENSION #2 OF THE TWO-YEAR
CONTRACT WITH BEST QUALITY CLEANING INC. FOR JANITORIAL
SERVICES AT THE POLICE AND EMERGENCY MANAGEMENT
HEADQUARTERS IN THE NOT-TO-EXCEED AMOUNT OF \$27,000**

WHEREAS the VILLAGE OF BENSENVILLE (hereinafter "Village") is a municipal corporation established and existing under the laws of the State of Illinois pursuant to the Illinois Municipal Code, 65 ILCS 5/1-1-1 *et seq*, and

WHEREAS the VILLAGE is empowered to make all agreements, contracts, and engagements and to undertake other acts as necessary in the exercise of its statutory powers, and

WHEREAS the Village owns and maintains the new Police and Emergency Management Headquarters at 345 E. Green Street, Bensenville, and

WHEREAS the Village contracts out the janitorial services required at the Police and Emergency Management Headquarters, and formally opened bids on November 28, 2018, and

WHEREAS, Best Quality Cleaning Inc., was the low bidder, and

WHEREAS, 2020 is Year Two (2) of a Two (2) Year Contract, and

WHEREAS, the Contract includes possibilities of extensions, and

WHEREAS, the Village and Contractor will enact Extension # 2.

NOW THEREFORE BE IT RESOLVED by the Board of Trustees of the Village of Bensenville, Counties of DuPage and Cook, Illinois as follows:

SECTION ONE: The recitals set forth above are incorporated herein and made a part hereof.

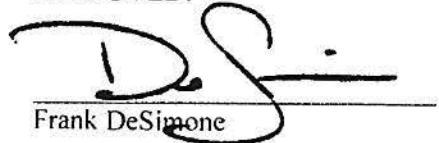

SECTION FOUR: This Resolution shall take effect immediately upon its passage and approval as provided by law.

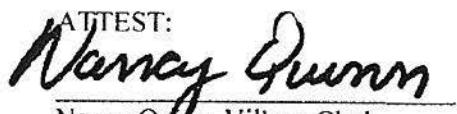
SECTION FIVE: This Resolution is passed and approved by the President and Board of Trustees of the Village of Bensenville, Illinois, dated November 16, 2021.

**EXTENSION # 2 OF THE CONTRACT FOR
2022 JANITORIAL SERVICES FOR THE POLICE DEPARTMENT

THIS EXTENSION OF AGREEMENT is made this 16 day of November, 2021, between the Village of Bensenville, Illinois (hereinafter "OWNER"), whose principal address, for the purposes of any notice required herein, is: Director of Public Works, 717 E. Jefferson Street, Bensenville, Illinois 60106, and Best Quality Cleaning (hereinafter "CONTRACTOR"), whose principal address, for the purposes of any notice required herein are: 10015 Pacific Avenue, Franklin Park, IL 60131

OWNER and CONTRACTOR acknowledge and mutually agree as follows:

1. OWNER and CONTRACTOR entered into a two (2) Year Contract for 2019-2020 Janitorial Services for the Police Department for the Village of Bensenville, Illinois.
2. The Two (2) Year Contract includes possibilities of Extensions
3. OWNER and CONTRACTOR hereby enacts the Extension #2 for 2022 Janitorial Services for the Police Department at 345 E Green Street, Bensenville, IL
4. Total cost for 2022 is \$27,000
5. The OWNER hereby informs CONTRACTOR that it may terminate contract in with a 60-day written notice.
6. Any and all other provisions of the Agreement (or subsequent Amendments) not otherwise amended herein shall remain applicable, governing and in full force and effect throughout the Extended Term of the Agreement.
