The information in question has not been publicly cited and identified by the Village President.

Additionally, portions of email correspondence reflecting communications between the Village's attorneys and Village staff have been withheld as exempt from disclosure under Section 7(1)(m) of FOIA, which exempts from inspection and copying communications between the Village and its attorneys that would not be subject to discovery in litigation. 5 ILCS 140/7(1)(m).

You have the right to have the partial denial of your FOIA request reviewed by the Public Access Counselor (PAC) at the Office of the Illinois Attorney General. 5 ILCS 140/9.5(a). You may file your Request for Review with the PAC by writing to:
