AN ORDINANCE PROVIDING FOR THE ANNEXATION
OF CERTAIN REAL ESTATE TO BENSENVILLE, ILLINOIS

WHEREAS, a written Petition, signed by all of the owners of record, there being no electors residing upon the territory, has been filed with the Village of Bensenville, DuPage and Cook Counties, Illinois; and

WHEREAS, said territory is not within the corporate limits of any municipality, but is contiguous to the Village of Bensenville, DuPage and Cook Counties, Illinois; and

WHEREAS, said Petition is in proper form;

NOW, THEREFORE, BE IT ORDAINED by the President and Board of Trustees of the Village of Bensenville, DuPage and Cook Counties, Illinois, as follows:

SECTION ONE:

That part of the Northwest fractional quarter of Section 19, Township 40 north, range 12, east of the third principal meridian, described as follows: beginning at the center line of Franklin Avenue at a point 500.0 feet (measured at right angles) east of the west line of said section line; thence south on a line 500.0 feet east of and parallel with the west line of section line, 407.53 feet; thence east perpendicular to the last described parallel line, 132.23 feet; thence north parallel with the west line of said section line to the center line of Franklin Avenue; thence northwesterly along the center line of said Franklin Avenue to the place of beginning, except therefrom the north 33.0 feet thereof, heretofore annexed to the Village of Bensenville, in Cook County, Illinois; which property is outside of, but contiguous to the limits of the Village of Bensenville.

be, and the same is, hereby annexed to the Village of Bensenville, DuPage and Cook Counties, Illinois.

SECTION TWO:

That an accurate map of the territory annexed be, and the same is, hereby attached to and made part of this Ordinance.

SECTION THREE:

That this Ordinance is subject to the payment of a connection fee for making municipal sewer and/or water services available to said real estate, to be paid at the time the application for building permit is made. The fee shall be, TWO HUNDRED SEVENTY-FIVE & .00/100 (\$275.00) DOLLARS single family; multi-family residential units, ONE HUNDRED FIFTY & .00/100 (\$150.00) DOLLARS for each one (1) bedroom and SEVENTY-FIVE & .00/100 (\$75.00) DOLLARS for each additional bedroom unit; industrial and commercial, FIVE HUNDRED FIFTY & .00/100 (\$550.00) DOLLARS for five thousand (5,000) square feet or less of building area plus seven cents (\$0.07) per square foot over five thousand (5,000) square feet.

SECTION FOUR:

That all Ordinances, or parts of Ordinances, in conflict with this Ordinance be, and the same are, hereby repealed.

SECTION FIVE:

That this Ordinance shall take effect immediately upon its passage.


